LOGISTICS BASE IN ALBANY, GEORGIA AND VARIOUS LOCATIONS AFFILIATED WITH THE FORT BENNING CONTRACTS TO PROVIDE CUSTODIAL SERVICES. THESE SERVICES ALLOWED EMPLOYEES TO DEVELOP PROPER WORK ATTITUDES AND HABITS AS WELL AS ACQUIRE NEW SKILLS TO ENABLE THEM TO WORK IN COMPETITIVE EMPLOYMENT ENVIRONMENTS. POWER WORKS PROVIDED EMPLOYMENT OPPORTUNITIES TO 103 PEOPLE THROUGH ITS FEDERAL GOVERNMENT CONTRACTS.
