DURING THE CURRENT YEAR, THE ORGANIZATION OPERATED CUSTODIAL AND GROUNDS MAINTENANCE CONTRACTS AT FORT BENNING, GEORGIA AND THE MARINE CORPS LOGISTICS BASE IN ALBANY, GEORGIA WITH 75% OR GREATER DIRECT LABOR HOURS PERFORMED BY INDIVIDUALS WITH DOCUMENTED DISABILITIES. THESE SERVICES PROVIDE EMPLOYEES WORK ACCOMMODATIONS FOR THEIR DISABILITIES WHILE DEVELOPING BEHAVIORS AND TO ENABLE THEM TO WORK IN COMPETITIVE EMPLOYMENT ENVIRONMENTS. POWER WORKS PROVIDED EMPLOYMENT OPPORTUNITIES TO 116 PEOPLE THROUGH ITS FEDERAL GOVERNMENT CONTRACTS. PERSONS SERVED THROUGH EMPLOYMENT EARNED AN AVERAGE HOURLY WAGE OF \$9.46.
